



# UPaisa (Branchless Banking) Schedule of Charges From 04-07-2024 to 30-09-2024

#### Ucash (Nano Loan)

The fees for UCash loans are applied weekly and are subject to any applicable taxes. The fee structure works in slabs:

For loans up to PKR 100, a base fee of PKR 5 plus tax is applicable.

For every additional PKR 100 borrowed, an extra PKR 5 fee (plus tax) will be added.

Fees are collected upfront, with the first week's fee collected upon loan disbursement and subsequent weekly fees collected on the first day of each week.

Fees only apply during the maturity phase (4 weeks from the date of disbursement) and rollover phases (4 weeks from maturity).
