- 1. In addition to above withholding tax, excise duty, stamp duty, provincial federal tax or any other government tax announced from time to time are for client account and will be charged in addition to above rates where applicable.
- Account opened and maintained by students, widows and government, semi government (for salary or pension) and U bank staff for salary will be exempt from initial deposit requirement and regular bank service charges.
- 3. Legal documentation charges with regards to secured loan shall be recovered at actual from the customers.
- 4. Any Charges which are not covered under this schedule shall be recovered separately on case-to-case basis as per the agreement with the customer.
- 5. Management of the bank may waive any or all charges.





- Collateral Valuation Charges will be paid by applicant directly to bank's panel approved evaluator according to bank agreement with evaluator.
- Collateral Auction charges will be deducted from sale proceeds of collateral before transferring remaining amount to customer account at actual.
- In case of introduction of any new service, for which the bank charges the customer a fee during the tenor of this schedule shall be deemed covered and shall be separately mentioned in next schedule.
